In sum, a corporate resolution is sufficient and no plan of liquidation has to be adopted if none is required under state law. But once whatever required state procedure to formalize dissolution is followed, the corporation then has 30 days to file Form 966 with the IRS. 26 U.S.C. § 6043(a)(1). 26 C.F.R. § 1.6043-1(a).

The board of directors will vote to dissolve the organization, but its job doesn't end there.

Before making an important decision such as dissolving a nonprofit, the board of directors needs to reach consensus and take an official corporate action (a vote that is documented in minutes of the meeting) to affirm that dissolution is the right path.
